Constitutional Commission (No. 2) Act 1993

DIRECTION

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 11(1)(d) of the Constitutional Commission (No. 2) Act 1993 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby direct the Constitutional Commission to inquire into the following matters:—

- 1. Whether the Independent State of Papua New Guinea should retain the system whereby Her Majesty the Queen and here heirs and successors are the Sovereigns and Heads of State of Papua New Guinea or whether the country should become a Republic or otherwise adopt an alternative form of government.
- 2. If the Commission recommends changes in the form of government, within what time-frame such changes should take place.
- 3. Whether changes need to be made to all or any offices established under the Constitution in order better to co-ordinate the powers, responsibilities and accountability of such offices.
- 4. Whether there is a need to change the name of the country from Papua New Guinea to another suitable name and, if so, to recommend a name.
- 5. Whether there is a need for a National Anthem as envisaged by Section 3(1)(e) of the Constitution and what song should be adopted as the National Anthem.
- 6. What provisions should be contained in the Organic Laws on the Integrity of Political Parties and of Candidates in Elections which are required by Subdivision VI. 2. H of the Constitution in order to protect elections from outside or hidden influence.
- 7. Whether changes need to be made to ensure that, while freedom of the Press is maintained, owners, editors and journalists of all elements of the media are accountable and that persons aggrieved by media abuses have accessible redress.
