  - (i) his debts and other liabilities; and
  - the names and residences (so far as they are known to him) of his creditors; and
  - (iii) the causes of his inability to meet his engagements;
- 4. Tom Penias Rangip pay the Petitioner's costs of and incidental to these proceedings to be taxed if not agreed;
- 5. The time for the entry of this Order be abridged to the date of
