National Capital District Commission (Amendment) Act 1992

REVOCATION OF APPOINTMENT AND APPOINTMENT OF MEMBERS OF NATIONAL CAPITAL DISTRICT COMMISSION

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 4 of the *National Capital District Commission (Amendment) Act 1992*, and all other powers me enabling, acting with, and in accordance with, the advice of the Minister for Provincial Affairs and Village Services, (by virtue of the authority conferred on him by Section 4(1)(a), (b) & (c) of *National Capital District Commission (Amendment) Act* 1992., hereby:—
 - (a) Revoke the appointment of persons specified in Column 1 of Schedule 1 to be members of the National Capital District Commission.
 - (b) Re-appoint and appoint persons specified in Column 2 of Schedule 1 to be members to represent that ward specified in Column 3 of the National Capital District Commission.
 - (c) Appoint and re-appoint members elected by Motu-Koitabu Council to represent Motu-Koita Council, and the members of the National Parliament for the NCDC and other NCD electorates in accordance with Section 4(1)(a) & 4(1)(c).
 - (d) The members specified in Column 2 of Schedule 1 and Schedule 2 are to hold office for three (3) years in accordance with Section 4(2)(b).
