Customs Tariff Act 1990

SUBSTITUTION OF REDUCED RATE OF IMPORT DUTY

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9 (1) (b) of the *Customs Tariff Act* 1990, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, in relation to the goods specified in the Schedule:—

- (a) revoke all previous substitutions of reduced rates of import duty; and
- (b) substitute, until 31st December, 1995, 11% as the reduced rate of import duty, subject to such conditions as are specified in the Schedule.

Potatoes imported in bulk packing for exclusive use in the processing of potato chips and other potato products, provided the Director-General is satisfied on verification of documentary evidence.


Organic Law on Provincial Government
