# Fisheries Act 1994

# GULF OF PAPUA PRAWN FISHERY MANAGEMENT PLAN

THE NATIONAL FISHERIES AUTHORITY, by virtue of the powers conferred by Section 39 of the *Fisheries Act* 1994 and all other powers it enabling, hereby draws up the following Fishery Management Plan to take effect on and from the date of approval of the Minister:

# 1. CITATION.

This plan may be cited as the Gulf of Papua Prawn Fishery Management Plan 1995 (Fishery Plan).

# 2. THE GULF OF PAPUA PRAWN FISHERY MANAGEMENT AREA

The Gulf of Papua Prawn Fishery Management Area comprises all that area of the Gulf of Papua commencing on the west at the point of latitude 9 degrees South (9.00 ' 00"S), longitude 143 degrees 27 minutes East (143.27 ' 00 "E), being a point off Parama Island, thence run east until intersecting the 12 mile territorial limit, and thence follow the 12 mile territorial limit in an easterly direction until reaching a point due south of Cape Possession (the Fishery Area).

# 3. MANAGEMENT OBJECTIVES.

The objectives of the Fishery Plan are—

- (a) to restore fishery stocks and maintain them at a level capable of producing a maximum sustainable yield, as qualified by relevant environmental and economic factors; and
- (b) to adopt necessary conservation and management measures for bycatches and appropriate utilisation of the bycatch so as to avoid wastage;
- (c) to prepare the way for participation in the prawn industry by the immediate resource owners;
- (d) to apply a cautionary approach to conserving fishery stocks when there is a lack of or inadequate scientific information;
- (e) to establish a long-term management unit or project to monitor the prawn resources in PNG and carry out biological and fisheries ecological research. This unit or project will be technical and its operations to be funded by the Prawn Industry (the Industry). An economic impact analysis of management measures will also be carried out. The terms of reference for the management unit, or project, are to be drawn up after consultations within the industry.

# 4. MANAGEMENT MEASURES.

- The following measures are to take effect immediately.
- (a) Introduction of a closed fishing season from 1995 to allow new juvenile recruits to the fishery a period of growth before harvest. In 1995, the closure will extend from 1st February to 15th March as agreed in consultation with the Industry on 16th December, 1994.
- (b) Prawn trawling in Orokolo Bay fishing area, i.e. the trawl grounds from the month of the Vailala River of the easternmost point of the mouth of the Purari River (the Purari River mouth at a line 145 degrees 14 minutes East) will additionally be prohibited during a second period of fishery recruitment there, in order to promote the conservation and rapid growth of the recruit-sized prawns in Orokolo Bay during this period. In 1995, the closure of Orokolo Bay fishing area will extend from 1st November to 31st December as agreed in consultation with Industry on 16th December, 1994.
- (c) The Wafy studies on rainfall and juvenile recruitment should be completed as soon as possible and an ongoing research programme to monitor the level of juvenile recruitment should be established.
- (d) The timing and duration of the closed season will be adjusted annually on the basis of results of the annual research and monitoring programme of the Authority. The Industry will assist the monitoring each year by making two vessels available (which will retain their catch) during the first quarter of the year and these will work (one vessel from west and one from the east) according to a programme of research that will be detailed by the Authority, based on the method of transect survey with depth. Transect studies will similarly be carried out in collaboration with the Industry at Orokolo Bay during the fishery recruitment in the latter part of the calendar year with one chartered fishing vessel.

(e) During the closed season, artisanal prawn fishing will also be prohibited other than for research. The following potential prawn trawling grounds in waters outside of the 3-mile limit will be opened to prawn trawling by research permits, as requested by the Fishing Industry Association:—

- (i) in Western Province near the border with Indonesia; and
- (ii) in Oro Province; and
- (iii) in Central Province from Cape Possession to the border between Central and Milne Bay Provinces.
- (f) Identification and permanent closure of the prawn nursery area to commercial trawling, the 3-mile zone from Parama Island (Fly River) to the Vailala River, and the 3-mile zone associated with the Lakekamu Estuary, from the 146th Meridian of Longitude to Cape Possession (nr. Iokea). Areas of the 3-mile zone in the Fishery Area which are not defined above will remain closed to trawl fishing.
- (g) In order to regulate the concentrate of fishing effort at Kerema Bay, the Kerema Bay area will be closed for a period each year, as determined by the Authority from time to time. The basis for closure will be that the cumulative annual catch of banana prawns from the area exceeds a pre-determined limit set annually by the Authority. When this limit is reached the prawn operators will be notified and all commercial fishing effort in Kerema Bay will be relocated to the other fishing areas.
- (*h*) Reducing fishing effort by a reduction of the number of licences; 14 licences in 1995 (preference will be given to the resource owners); reduced to 13 licences by 1998 (preference will be given to the resources owners).
- (i) Policy guidelines for the issue of licences will be given to the general public by the Authority in 1995.
- (*j*) Bycatch will be reduced and utilised as follows—
  - (i) trials will begin in 1995 to minimise the fish bycatch by use of fish escape panels and fish exclusion grids, as agreed in consultations with the Industry on 16th December, 1994; and
  - (ii) it will be a condition of the licences in the long-term that Industry will utilise all of their commercial fish by catch. The offloading of fish to small tenders and dinghies owned by coastal fishing communities in the Gulf is to be encouraged. Bycatch log-books will be implemented in 1995 by the industry to record the total weight of marketable fish caught, thrown overboard, and landed, according to aggregate group, as specified, eg., sharks and turtles. Prawn trawl shots of greater than 90 minutes duration are to be discouraged, in the interests of conservation of turtles. In regard to the use of marketable trash fish, the objectives of this Fisheries Plan should be met in the longterm by Industry (reference pp. 71-74, Working Paper No.3, Report of the Marine Resources Specialist, November, 1994, Draft Final Report of ANZDEC Consultants, Asian Development Bank Technical Assistance No.2022 - PNG; Institutional Strengthening of the Department of Fisheries and Marine Resources; and
  - (iii) pilot projects will be established to investigate other power ways of utilising the fish-
    - (A) baitfish for tuna long-lining;
    - (B) aquaculture of grouper and barramundi utilising trash fish as feed;
      - (C) bait for trapping mud crabs in Western Province;
      - (D) feed for crocodile farms;
      - (F) fish silage or meal for pig or poultry farms (eg. the new poultry farm in Port Moresby).
- (k) In the long-term, the Industry will fund research and management of the Fishery Area. A stand-aline (independently-run) prawn management unit will be established under a memorandum of agreement between the Industry and Government. Staff will be selected jointly by an equally-represented committee from both the Industry and the Government. Funding will be partly from the Government and partly from the Industry. There will be defined management objectives and plans for achieving them, and prioritisation of the objectives. Fisheries sociological aspects will also be addressed. The unit will utilise the existing resources of the Authority for trials of new fishing technology and analysis of data. Fishing vessels may be chartered for agreed periods to monitor the recruitment and migration of juveniles. The prawn management unit would be based in Port Moresby. In consultation with the Industry, terms of reference, objectives and sources of funding are to be drawn up.
- (1) To facilitate the estimation of maximum economic yield, prawn operations will be required, at the close of each calendar year, to submit their average costs per trawl hour in the calendar year, to the Principal Scientist, Industrial Fisheries.
- (m) The observer programme will commence on 10th January, 1995. From a date to be specified by the Authority, all prawn fishing vessels will be required to carry tracking devices to enable radio position fixing by the Authority in Port Moresby. These tracking devices will also facilitate management and increase safety in navigation.

- (n) The two vessels currently licenced to trawl for prawns in both the waters of Torres Strait and Western Province (which are of - 22m overall length) will be permitted to trawl in the Fly River areas of the Fishery Area from 11th April to 31st December, and to have a joint license for Torres Strait water (PNG Area of Jurisdiction).
- (*o*) Prawns in the Gulf of Papua will be managed as on stock from Parama Island to Cape Possession, though it is recognised that there is some localisation of stock in both the Fly River and Freshwater Bay areas of the Gulf of Papua.

# CONTROL OF PRAWN FISHING IN PAPUA NEW GUINEA

I, Titus Philemon, Minister for Fisheries and Marine Resources, by virtue of the powers conferred by Section 52(3) of the *Fisheries Act* 1994 and all other powers me enabling, upon the recommendation of the Authority, hereby—

1. prohibit the taking of penaeid prawns at all times—

- (a) by boats owned by non-citizen companies or individuals; and
- (b) by boats whose registry is offshore; and
- (c) by boats exceeding 30 metres according to Papua New Guinea registered survey length; and
- (d) by boats with main engines with shaft power exceeding 410 kilowatts or 550 horsepower, as set out in the manufacturer's specifications; and
- (e)  $\Rightarrow$  by method of more than 4 main nets and 1 try net towed at the same time; and
- (f) by a method whereby the aggregate head rope (with mesh attached) for the main nets exceeds 60m, and 1 try net exceeds 6m head line; and
- (g) by a method whereby the head line of any one single main net exceeds 30m; and
- (h) by a method whereby the meshes for all nets, when measured diagonally stretched from knot to knot, are less than 50mm in body or cod end; and
  - (i) by method of an otterboard that is more than 5 square metres in area, per board; and
  - (j) by a beam trawl of greater than 6m beam length; and

2. determine that where area fishery management plan for a prawn fishery exists, additional restrictions may from time to time be applied and enforced under the plan.

# ORANGERIE BAY PRAWN FISHERY MANAGEMENT PLAN

I, Titus Philemon, Minister for Fisheries and Marine Resources, by virtue of the powers conferred by Section 39 of the *Fisheries Act* 1994 and all other powers me enabling, hereby draw up the following fishery management Plan to take effect on and from the date of approval of the Minister:

# 1. CITATION.

This plan may be cited as the Orangerie Bay Fishery Management Plan 1995 (Fishery Plan).

# 2. THE ORANGERIE BAY PRAWN FISHERY MANAGEMENT AREA

The Orangerie Bay Prawn Fishery Management Area comprises all that area of water from longitude 149 degrees 25 minutes East (149.25 \.00 "E), to longitude 150 degrees 5 minutes East (150.5 ' 00 "E), and from the coast-line out seaward to the 12 mile limit (the Fishery Area).

# 3. MANAGEMENT OBJECTIVES.

The objectives of the Fishery Plan are—

- (a) to restore fishery stocks and maintain them at a level capable of producing a maximum sustainable yield, as qualified by relevant environmental and economic factors; and
- (b) to adopt necessary conservation and management measures for bycatches and appropriate utilisation of the bycatch so as to avoid wastage;
- (c) to prepare the way for participation in the prawn industry by the immediate resource owners;
- (d) to apply a cautionary approach to conserving fishery stocks when there is a lack of or inadequate scientific information;
- (e) to establish a long-term management unit or project to monitor the prawn resources in PNG and carry out biological and fisheries ecological research. This unit or project will be technical and its operations to be funded by the Prawn Industry (the Industry). An economic impact analysis of management measures will also be carried out. The terms of reference for the management unit, or project, are to be drawn up after consultations within the industry.

# 4. MANAGEMENT MEASURES.

The following measures are to take effect immediately.

- The taking of penaeid prawns is prohibited—
  - (a) during the principal prawn growth period as defined from time to time by the Authority in consultation with the Industry; and
  - (b) by any kind of fishing in Mullins Harbour; and
  - (c) by a fishing fleet of more than 3 vessels; and
  - (d) by vessels of more than 14m PNG registered survey length or by vessels of more than 200 horsepower; and
  - (e) by method of more than 2 main nets and 1 try net; and
  - (f) by a method whereby the aggregate head rope (with mesh attached) for the main nets exceeds 40m, and one try net exceeds head line; and
  - (g) by a method whereby the head line of any one single main net exceeds 20m; and
  - (*h*) by boats operating from a port outside of Milne Bay Province.

# 5. EMERGENCY MANAGEMENT MEASURES.

The Executive Director may, from time to time, by written notice, make emergency measures as he deems necessary for the more efficient management of this Fishery Plan.

Professional Engineers Registration Act 1986

# NOTIFICATION OF REGISTRATION OF PROFESSIONAL ENGINEERS

I hereby notify that the engineers specified in the Schedule hereto are entitled to practice as professional engineers in accordance with Part V of the Act and to use the identifying title 'Reg Eng' after their names. A person, Company, Statutory Body, Government Body, or Organisation which employs an unregistered person as a Professional Engineer is guilty of an offence. An unregistered person who practices as a professional engineer is guilty of an offence. Applications for exemption from registration and the provisions of the Act may be made under Section 17.

**Employers of Professional Engineers should note:** 

- (1) a list, which shall cancel all previous lists, of persons currently registered under the Act shall appear annually in the *National Gazette* during the month of January; and
- an addendum to the annual list, of persons subsequently registered, or de-registered, shall appear as (2) required; and
- (3) Certificates issued to persons registered under this Act must be displayed in a prominent position in the office given as the place of practice.
