 - (b) in Schedule 22—
 - (i) in Column 3, by adding the following new Paragraph:—
 - "(b) Papua New Guinea Electricity Commission."; and
 - (ii) in Column 4, by inserting at the top the following:—

"Electricity Commission Act (Chapter 78) (All provisions except Ss.13(1), 16(2) and 17)".
