Other postal products and services, namely, Private Bags, Supply of Extra keys, Domestic and Overseas Parcels, Express Mail Service - both domestic and Overseas, Salim Moni Kwik (SMK), Kwik Piksa Leta (KPL) and Postal orders are open to market competition and therefore, the prices for these products and services, as and when altered, are subject to price notifications only.

2. The prices for domestic mail and post office boxes are exclusive of Provincial Sales and Services tax.

3. The effect of this order is to set Domestic postal mail charges and Annual Post Office box rentals.
