### REVOCATION OF PROCLAMATION OF CURFEW

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3 of the *Curfew Act* 1987 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, with effect from 5.00 am on Monday 25th November, 1996, revoke the Proclamation of Curfew dated 5th November, 1996 and published in *National Gazette* No. G92 on 6th November, 1996.

#### Curfew Act 1987

#### PROCLAMATION OF CURFEW

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3 of the Curfew Act 1987 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby require every person with the boundaries of—
  - (a) Central Province (being the area specified in the Organic Law on Provincial Boundaries); and
  - (b) the National Capital District (being the area specified in the Organic Law on the Boundaries of the National Capital District); and
  - (c) the City of Lae (being the area within the boundaries as set out in the Declaration of Town Boundaries of Lae dated 8th December, 1975 and published in National Gazette No. G1 on 2nd January, 1976); and
  - (d) that part of the Highlands Highway (otherwise known as the Okuk Highway) between the City of Lae and Waterais in Morobe Province; and
  - (e) the town of Bulolo (being the area within the boundaries set out in the Declaration of Town Boundaries of Bulolo dated 17th May, 1956 and published in Papua New Guinea Gazette No. 24 on 24th May, 1956; and
  - (f) the town of Wau (being the area within the boundaries as set out in the Declaration of Town Boundaries of Wau dated 8th June 1965 and published in the Papua New Guinea Gazette on 17th June, 1965; and
  - (g) the Highway from the City of Lae to Bulolo and Wau; and

(h) Western Highlands Province (being the area specified in the Organic Law on Provincial Boundaries) BUT NOT INCLUDING the City of Mount Hagen (being the area within the boundaries as set out in the Declaration of Town Boundaries of Mount Hagen dated 12th December, 1972 and published in Papua New Guinea Gazette No. 110 on 21st December, 1972,

to remain within doors between the hours of ten o'clock in the evening (10.00 p.m.) and four o'clock in the morning (4.00 a.m.) for a period commencing on and from ten o'clock in the evening (10.00 p.m.) on Monday 25th November, 1996 until four o'clock in the morning (4.00 a.m.) on Wednesday 8th January, 1997.
