 - (i) Departmental Head of the Department of Transport;
 - (ii) Departmental Head of the Department of Works; and
 - (d) establish the office of Departmental Head of the Department of Transport and Works; and
 - (e) amend the Determination of Functions of Departments dated 2nd August, 1995 and published in National Gazette No. G72 on 3rd August, 1995—
 - (i) by repealing Schedule 18 and replacing it with the following:—
