Customs Tariff Act 1990

REDUCED RATE OF IMPORT DUTY

I, Wiwa Korowi, G.C.M.G., K.St.J., by virtue of the powers conferred by Section 9(1) (a) of the Customs Tariff Act 1990 and all other powers me enabling, acting with, and in accordance with the advice of the National Executive Council, hereby exempt with effect from 28th July, 1995 from import duties the goods specified in the Schedule subject to the conditions specified in the Schedule.

SCHEDULE

The following goods imported by RD Tuna Canners and RD Fishing—

- (a) required for the construction, installation, provision, expansion, maintenance and operation of the facilities required for the Madang Tuna Cannery; or
- (b) otherwise required for the purposes of Madang Tuna Cannery (the abovementioned assets being together here-inafter called the "Goods") PROVIDED THAT there is not a product substantially the same as the Goods or any of them which is:
 - manufactured or produced in PNG; and
 - whose price in PNG is not more than the general protective import duty rate applied from time to time to general goods imported into PNG or 30%, whichever is the lesser, of the product the RD TUNA CANNERS and RD FISHING wishes to purchase outside PNG.

Other goods agreed to be exempted as specified in the Agreement dated 28th July, 1995 with RD Tuna Canners Pty Ltd and RD Fishing (PNG) Pty Ltd and for the Period of exemption covered in the Agreement.
