A Law to alter the Organic Law on Provincial Governments and Local-level Governments and for related purposes.

MADE by the National Parliament.

JOINT DISTRICT PLANNING AND BUDGET PRIORITIES COMMITTEE (AMENDMENT OF SECTION 33A).

Organic Law on Provincial Governments and Local-Level Governments (Amendment No. 2) Law-continued

Section 33A of the Organic Law on Provincial Governments and Local-Level Governments is amended:—

- in Sub-section (2) by repealing Paragraph (b); and
- by repealing Sub-sections (5) and (6) and replacing them with the following:—
 - "(5) The National Government shall, within the first quarter of each fiscal year, make a payment of all the monies lawfully available for the purpose of the Rural Action Programme, to the Joint District Planning and Budget Priorities Committee for the Committee to perform its functions under Subsection (3)"; and
 - "(6) The monies referred to in Sub-section (5) shall be:--

- paid through the Provincial and District Tréasury; and
- paid directly to the appropriate Joint District Planning and Budget Priorities Committee by the Provincial and District Treasury"; and
- "(7) An Act of the Parliament shall make provision for other functions and powers of, and the administrative arrangements for the Committee".
