National Capital District (Transfer of Assets, etc.,) Act 1996

APPOINTMENT OF VESTING DATE

I. Rabbie Namaliu, K.C.M.G., M.P., Acting Governor-General, by virtue of the powers conferred by Section 3 of the *National Capital District (Transfer of Assets, etc..)* Act 1996, and all other powers me enabling, acting with, and in accordance with, the advice of the Minister for National Planning, hereby appoint 1st November, 1996 to be the vesting date on which date the property, rights and liabilities of the National Capital District Commission or any other person or corporation whatever in respect of all water treatment and supply services and all sewage treatment and disposal services of or pertaining to the National Capital District (being the property, rights and liabilities specified in the Schedule hereto) are transferred to and vested in NCD Water and Sewerage Pty Limited.

SCHEDULE

- All property and all rights and liabilities of the National Capital District Commission and of any other
 person or corporation of or pertaining to the acquisition of raw water, water treatment and supply services the treatment and disposal of sewage, of or pertaining to the National Capital District.

Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Rabbie Namaliu, K.C.M.G., M.P., Acting Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the Customs Tariff Act 1990, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from payment of import duty the goods specified in the Schedule for the period specified in the Schedule and subject to such conditions as are specified in the Schedule.

SCHEDULE

- (a) Unprocessed seafood imported by Nako Fisheries Pty Ltd., which the Commissioner-General is satisfied is imported for processing and re-export to Australia and which is subsequently re-exported to Australia, said exemption to be from 1st October, 1996 until 31st March 1997 inclusive;
- (b) Specially waxed pre-printed packaging materials imported by Nako Fisheries Pty Ltd., which are approved by the Commissioner-General on his being satisfied that such materials are not manufactured in Papua New Guinea, said exemption to be from 1st October, 1996 until further notice.
