#### FIXING OF TIME AND DATE OF MEETING OF THE PARLIAMENT

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 124 of the Constitution and Section 1 of the *Organic Law on the Calling of Meetings of the Parliament* and all other powers me enabling, after consultation with the outgoing Prime Minister and Speaker fix 10 o'clock in the forenoon of Tuesday 22nd July, 1997 as the time and date on which the Parliament shall meet for the first time after the 1997 General Election.

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(1)(f) of the Constitution and Sections 6 and 18 of the *Defence Act* (Chapter 74), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby, with effect on and from 3rd June, 1997, revoke Paragraphs (b) and (c) of the instrument of revocation of acting appointment of Commander and promotion and appointment of Brigadier-General and Commander of the Papua New Guinea Defence Force dated 3rd June, 1997 and published in the *National Gazette* No. G44/97 on 3rd June, 1997.

# PROMOTION AND APPOINTMENT OF BRIGADIER-GENERAL AND COMMANDER OF PAPUA NEW GUINEA DEFENCE FORCE

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(1)(f) of the Constitution and Sections 6 and 18 of the *Defence Act* (Chapter 74), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby—
  - (a) promote Colonel Leo Nuia to the rank of Brigadier-General; and
  - (b) appoint Brigadier-General Leo Nuia to be Commander of the Papua New Guinea Defence Force

with effect on and from 3rd June, 1997.
