# NOTICE OF AMENDMENT TO THE MILNE BAY BECHE-DE-MER FISHERY MANAGEMENT PLAN

I, Sir Mekere Morauta Kt, M.P., Minister for Fisheries, by virtue of the powers conferred by Section 39 of the Fisheries Act 1994 and clause 10 of the Milne Bay Beche-de-mer Fishery Management Plan, and all other powers me enabling, upon the recommendation of the Authority, hereby:—

Amend Clause 6(5) of the Milne Bay Beche-de-mer Fishery Management Plan by repealing paragraph (5) and replacing it with the following:—

"(5) All harvesting, buying, selling and storage of beche-de-mer shall cease at the begining of the closed season or once the TAC for the year is reached. The compulsory closed season in each year shall be from 1st October to 30th November to protect spawning of some of the most common high value species. In event that the TAC for the year is reached before the closed season, the fishery shall be closed until 30th November. No product will be kept in storage after one (1) week from the start of the closure.
