A Law to alter Sections 101 and 102 of the Constitution.

MADE by the National Parliament.

MEMBERSHIP (AMENDMENT OF SECTION 101).

Section 101 of the Constitution is amended in Subsection (1)(c) by repealing the word "three" and replacing it with the following:-

"four"

NOMINATED MEMBERS (AMENDMENT OF SECTION 102).

Section 102 of the Constitution is amended by adding after the words "Member of the Parliament" the following:-

"one of whom shall represent the churches, nominated by the National Council of Christian Churches in Papua New Guinea, which shall be established by an Act of Parliament".
