Excise Tariff Act (Chapter 107)

EXTENSION OF EXEMPTION FROM EXCISE DUTY

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3(1)(a) of the Excise Tariff Act (Chapter 107), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby extend from 16th September, 2000 until further notice the exemption from excise duty on motor vehicles and other goods imported for use in Papua New Guinea's Silver Jubilee Celebrations (said exemption dated 1st September, 2000 and published in National Gazette No. G110 on 1st September, 2000), subject to the condition contained in said exemption.

Customs Tariff Act 1990

EXTENSION OF EXEMPTION FROM IMPORT DUTY

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the Customs Tariff Act 1990, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby extend from 16th September, 2000 until further notice the exemption from import duty on flags, plaques, medals and other materials imported for use in Papua New Guinea's Silver Jubilee Celebrations (said exemption dated 15th June, 2000 and published in National Gazette No. G71 on 15th June, 2000), subject to the condition contained in said exemption.

Value Added Tax Act 1998

EXTENSION OF SUBSTITUTION OF REDUCED RATE OF VALUE ADDED TAX

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 24(10) and (11) of the Value Added Tax Act 1998, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby extend from 16th September, 2000 until further notice, the substitution of a reduced rate of value added tax which shall be zero percent on flags, plaques, medals and other materials supplied or imported for use in Papua New Guinea's Silver Jubilee Celebrations (said substitution being dated 15th June, 2000 and published in National Gazette No. G71 on 15th June, 2000), subject to the condition contained in said substitution.
