The said group claims the following qualifications for recognition as an incorporated land group:—

- (1) its members are from Para Village.
- (2) its members regard themselves and are regarded by other members of the said clan as bound by the common customs and beliefs.
- (3) it owns customary land in Komo Local Government Council Area, Southern Highlands Province.
