REDUCED RATE OF IMPORT DUTY

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the *Customs Tariff Act* 1990 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby reduce, with effect from the date of publication in the *National Gazette*, to 10.00% the rate of import duty payable on all items specified in Schedule 2 which but for this reduction would have attracted a higher rate of import duty, based on the average of the total of the import and excise duties payable on the items specified in Column 2 of Schedule 1.
