Public Services (Management) Act 1995

REVOCATION OF APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEAD

- I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Sections 25 and 27 of the *Public Services (Management) Act* 1995, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council given after consultation with the Public Services Commission, hereby—
 - (a) revoke the appointment of Puka Temu as Secretary for the Department of Health dated 14th April, 2000 and published in the *National Gazette* No. G38 of 14th April, 2001; and
