AMENDED CREDITOR'S PETITION

THE petition of National Provident Fund Board of Trustees of P.O. Box 5791, Boroko, National Capital District, Papua New Guinea, shows that Jimmy Maladina, lawyer, is indebted to it in the sum of CAN\$3,000 being an amount greated than K100 being the prescribed amount under the *Insolvency Act*.

The Petitioner is informed and believes that Jimmy Maladina lately and while so indebted to the Petitioner committed the following act of insolvency:

- (a) that he made a fradulent conveyance (or gift or delivery or transfer) of his property (or part of his property) to Property Investment Consultants Limited by transfer of the property described as Allotment Section Boroko on 11th December, 2000 for the amount of K80,000;
- (b) with intent to defeat (or delay) his creditors departed out of the country and to the knowledge and information of the Petitioner has remained out of the country since the 1st day of May, 2000.

The Petitioner therefore prays that Jimmy Maladina may be adjudged insolvent.
