## DETERMINATION OF CUSTOMARY LAND OWNERSHIP OF PORTION 168 MILINCH KARIUS FOURMIL WABAG, PLANT SITE AND WATERLINE EASEMENT OF THE HIDES GAS PROJECT

We, the Minister for Petroleum and Energy, Hon. Roy Yaki, LLB., MP., and the Director for the Oil and Gas Act, Joseph Gabut, by virtue of Section 169 of the Oil and Gas Act 1998, and all other powers us enabling, hereby make the fol-

lowing interim determination on the ownership of the Hides Gas Plant Site "Portion 168C, Milinch Karius, Fourmil Wabag of the Hides Gas Project.

Having received the court decision C/A 315 of 20th July, 2001, we the Minister and the Director responsible for the implementation of the Oil and Gas Act 1998 make the following determination: -

- Pina clans are the legal customary landowners of "Portion 168C, Milinch Karius, Fourmil Wabag, Hides 1. Gas Plant Site and Waterline Easement in the Hides Gas Project in Tari, Southern Highlands Province.
- In accordance to the court decision all royalties held in trust shall be released to the Pina Clans. 2. This determination takes effect immediately.
