- (a) Minister for Mining shall have the responsibilities of the Minister for Foreign Affairs, Minister for Planning and Implementation and Bougainville Affairs; and
- (b) Prime Minister shall have the responsibilities of the Minister for Defence; and
- (c) Minister for Home Affairs shall have the responsibilities of the Minister for Police; and
- (d) Minister for Culture and Tourism shall have the responsibilities of the Minister for Petroleum and Energy; and
- (e) Deputy Prime Minister shall have the responsibilities of the Minister for Justice; and
- (f) Minister for Lands and Physical Planning shall have the responsibilities of the Minister for Trade and Industry; and
- (g) Minister for Agriculture and Livestock shall have the responsibilities of the Minister for Environment and Conservation; and
- (h) Minister for Finance shall have the responsibilities of the Minister for Transport and Civil Aviation,

for a period commencing on and from 24th February 2001 up until such time the Ministers resume their duties.
