National Land Registration Act (Chapter 357)

NOTICE UNDER SECTION 7

I, Hon. John Pundari, Minister for Lands, by virtue of the powers conferred by Section 7 of the National Land Registration Act (Chapter 357) and all other powers me enabling hereby intimate that it is my intention to declare not earlier that the expiry of three months following the publication of this notice in the National Gazette, that the land specified in the Schedule:—

- 1. (a) is Government land; and
 - (b) was acquired before Independence Day by the pre-Independence Administration of Papua New Guinea; and
 - (c) is required for a public purpose, namely establishment and extension of school and associated improvements.
- 2. Any person aggrieved by this notice may make representation to me within 60 days from:—
 - (a) the date of publication of this notice in the National Gazette; and
 - (b) notice given by me in accordance with Section 52 of the National Land Registration Act (Chapter 357).
