#### REVOCATION OF APPOINTMENT AND APPOINTMENT OF MEMBERS AND ALTERNATE MEMBERS OF THE SMALL BUSINESS DEVELOPMENT CORPORATION BOARD

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 9 and 10 of the *Small Business Development Corporation Act* 1990, and all other powers me enabling, acting with, and in accordance with the advice of the National Executive Council, given after considering a recommendation from the Minister for Trade and Industry, hereby:—

- (a) revoke the appointment of:-
  - (i) each person specified in Column 2 of Schedule 1 as Member of the Small Business Development Corporation Board under the provision specified in Column 1 of the Schedule 1 opposite his name as published in *National Gazette* No. G77 of May, 2002; and
  - (ii) each person specified in Column 3 of Schedule 1 as an Alternate Member of the Board for the Member opposite his name as published in *National Gazette* No. G77 of May, 2002; and
- (b) appoint:---
  - (i) each person specified in Column 2 of Schedule 2 as Member of the Small Business Development Corporation Board under the provision specified in Column 1 of Schedule 2 opposite his name; and
  - each person specified in Column 3 of Schedule 2 as Alternate Member of the Board for the Member opposite his name,

for a period of two years with effect on and from the date of publication of this instrument in the *National Gazette*.

# REVOCATION OF APPOINTMENT AND APPOINTMENT OF ACTING PROVINCIAL ADMINISTRATOR

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 73(3) of the Organic Law on Provincial Governments and Local-level Governments, and Section 31 of the *Public Services (Management) Act* 1995, and all other powers it enabling, after considering a list comprising the names of three persons submitted by the Minister for Provincial and Local Government Affairs (the powers of the Southern Highlands Provincial Government having been withdrawn) and after consultation with the Public Services Commission, hereby:—

- (a) revoke the appointment of Uhae Iabo as Provincial Administrator of the Southern Highlands Province as published in the *National Gazette* No. G77 of 26th June, 2001; and
- (b) appoint Warren Temokang as Acting Provincial Administrator of the Southern Highlands Province until further notice,

with effect on and from 25th April, 2003.
