National Narcotics Control Board Act 1992

REVOCATION OF APPOINTMENT OF MEMBERS AND APPOINTMENT OF MEMBERS OF THE NATIONAL NARCOTICS CONTROL BOARD

I, Yawa Silupa, Minister for Internal Security, by virtue of the powers conferred by Sections 4 and 6 of the *National Narcotics Control Board Act* 1992, and all other powers me enabling, after considering recommendations for relevant Departmental Heads, the Melanesian Council of Churches and the Evangelical Alliance, hereby:—

- (a) revoke all previous appointments of members of the National Narcotics Control Board; and
- (b) appoint each person specified in Column 2 of the Schedule to be a member of the National Narcotics Control Board appointed under the provision of the Act specified in Column 1 opposite his name and the person specified in Column 3 of the Schedule opposite his name to be his alternate.

for a period of three years commencing on and from the date of publication of this instrument in the *National Gazette*.
