AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITES OF MINISTERS

- (f) in Schedule 15 (Minister for Higher Education, Research, Science and Technology) in Column 1, by deleting "Roy Biyama" and inserting "Brian Pulayasi"; and
- (g) in Schedule 16 (Minister for Housing) in Column 1, by inserting "Atumeng Buhupe"; and
- (h) in Schedule 20 (Minister for Labour and Industrial Relations) in Column 1, by deleting "Tom Tomiape" and inserting "Roy Biyama"; and
- (i) in Schedule 21 (Minister for Lands and Physical Planning) in Column 1, by deleting "Michael Nali" and inserting "Petrus Thomas".
