- (d) Dr Osia Gogobwana Gideon, a person with qualifications on conservation, maintenance of ecosystems and their bio-diversity under Section 17(1(e); and
- (e) Rodney Kameata, a person with qualifications on socio-ecomomics and social impact assessment under Section 17(1(f),

to be members of the Environment Council for a period of three years commencing on and from the date of publication of this instrument in the National Gazette.
