- DISTRICT SUPPORT GRANTS (AMENDMENT) OF SECTION 95A).
  Section 95A of the Organic Law on Provincial Government and Local-level Government is amended:—
  - (a) in Subsection (1)(a) by repealing the words "one half of which" and substituting "K1,250,000.00"; and
  - (b) in Subsection (1)(b) by repealing the words "one half of which" and substituting "K250,000.00"; and
  - (c) in Subsection (2) by repealing the amount "K300,000.00" and substituting in its stead "K1,000,000.00"; and
  - (d) in Subsection 4 by repealing paragraph (a) and (b) and replacing in their stead the following:—

"(a) K1,000.000.00 for the fiscal year commencing 1st January, 2006; and

- (b) K1,500,000.00 commencing on 1st January, 2006 and for each succeeding fiscal year, for each open electorate.".
- PROVINCIAL SUPPORT GRANTS (AMENDMENT) OF SECTION 95B).
  Section 95B of the Organic Law on Provincial Government and Local-level Government is amended:—
  - (a) in Subsection (1)(a) by repealing the words "one half of which" and substituting "K1,250,000.00"; and
  - (b) in Subsection (1)(b) by repealing the words "one half of which" and substituting "K250,000.00"; and
  - (c) in Subsection 2 by repealing paragraph (a) and (b) and replacing in their stead the following:----
    - "(a) K1,000,000.00 for the fiscal year commencing 1st January, 2006; and
    - "(d) by adding the following new Subsection:
      - "(6) Notwithstanding Subsection (5), a Member representing the provincial electorate shall give to each District in his electorate not less than ten percent (10%) of monies referred to in Subsection (4)(b)(ii), and, it shall be the responsibility of the Joint Provincial Planning Budget Priorities Committee to ensure that monies are paid directly to each District for projects identified or as the case may be.".

**TRIBUNALS (AMENDMENT OF SECTION 27).** 1.

Section 27 of the Principal Law is amended in Subsection (5) by deleting Paragraph (a) and replacing it with the following:---

"he or she, other than a member of the Parliament, be dismissed from office or position"
