IT is hereby notified for general information that the Head of State, Acting with, and in accordance with, the advice of the National Executive Council under the Telecommunications Act 1996, has made a Regulation to be known as the Telecommunications (Cable Television Service Licence Fees) Regulation 2005 which is deemed to have come into operation on the 1st January, 2005.

This Regulation prescribes the following Cable Television Service Fees payable by Cable Television Operators to the Independent Consumer and Competition Commission as follows:

Cable Television Service Application Fee

The fee for an application under Section 117 of the Act for cable television licence is K100.00.

Cable Television Service Application Fee

The annual licence fee, required under Section 118 of the Act, for each cable television shall be an amount equal to one-twentieth of the Annual Subscription Fee multipilied by the number of Customers, multiplied by 12 months.
