*National Identity Act (Chapter 9)**Regulatory Statutory Authorities (Appointment to Certain Offices) Act 2004***APPOINTMENT OF ACTING CHIEF OF STATE PROTOCOL AND CEREMONIES**

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 10M of the *National Identity Act* (Chapter 9) and Section 9 of the *Regulatory Statutory Authorities (Appointment to Certain Offices) Act 2004*, and all other powers it enabling, hereby appoint David Tauaole to be Acting Chief of State Protocol and Ceremonies for the following periods of three months:-

- (i) from 1st April, 2005 to 30th June, 2005; and
- (ii) from 1st July, 2005 to 30th September, 2005; and
- (iii) from 1st October, 2005 to 31st December, 2005 or to the date of appointment of a substantive Chief of State Protocol and Ceremonies, whichever happens first.

*National Road Safety Council Act 1997***OPERATIONAL INSTRUCTIONS**

I, Michael Mayberry, Chairman, by virtue of the powers conferred by Section 45 of the *National Road Safety Council Act 1997* and all other powers me enabling, acting with, and in accordance with the advice of the a/Executive Director for National Road Safety Council Services, hereby fix the date of Road Safety Campaigns during the normal working hours as the date of this gazettal notice on which the Randon Road Safety Awareness Campaigns will come into operation through out the country each year. Hence, I hereby Schedule the aid of individuals as per the attached list from here forth to be Road Safety Inspectors for the purpose of these awareness campaigns in PNG. Henceforth, the written notice referred to in Section 41 of the Act is herewith to be known and used by the Inspectors as NRSC TIN.

The Road Safety Inspectors will be conducting Road Safety Awareness Campaigns as well as Vehicle Integrity Checks on all road users for the purpose of preventing road accidents. The whole aim of this Awareness Campaign is to implement the policy functions as stipulated in Section 4(d), (e), (f), (i), (k), (l) and (n) of the *NRSC Act*.

Any person or agency obstructing these operations or undertaking such operations without the approval of the National Road Safety Council will be in breach of the *NRSC Act* and liable for a fine of K2000.00 as stipulated in the Section 46 of the *NRSC Act*. Henceforth, issuing of NRSC Traffic Infringment Notices (TIN) without the NRSC's authorization will face likely prosecution under the *Finace Management Act*. Only NRCS has been authorized by the Secretary of the Department of Finance Management to collect NRCS TIN fines for the purposes of Road Safety Campaigns as stipulated in Section 31 (e), (f) and (g) of the *NRSC Act*.

**Operational Instructions - continued**

The NRSC with a new concept of BONUS payment will pay up to 20% of a completed TIN book relative to only the paid TINS, minus any recovery costs applied to its employees, any person or agency engaged any where in Papua New Guinea to enforce, promote road safety thus collect TIN fines as stipulated in Section 4 and Section 26 of the NRSC Act 1997.

A person who on being required under this Act to furnish to the Council any NRSC Traffic Infringement Notice or information, fails to comply during this period is guilty of an offence and liable for a fine of K1000 or imprisonment for a term not exceeding 12 months or both.
