Organic Law on National and Local-level Government Elections

#### APPOINTMENT OF MEMBERS OF THE BOUNDARIES COMMISSION

I, Paulias Matane, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by the Constitution and the Organic Law on National and Local-level Government Elections and all other powers me enabling:—

- under Section 193(1)(b) and (2) of the Constitution and Section 27 of the Organic Law on National and Local-level Government Elections, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Service Commission and any appropriate Permanent Parliamentary Committee, hereby appoint Philip Ame to be a member of the Boundaries Commission for a term of six years with effect on and from 9th March, 2005; and
- (b) under Section 193(1)(b) and (2) of the Constitution and Sections 27 and 31(2) of the Organic Law on National and Local-level Government Elections acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Service Commission and any appropriate Permanent Parliamentary Committee, for special reasons hereby:—
  - (i) appoint Vimuru lagata and Jerry Poivi, being persons of high standing in the community, maturity and experience in election management and election related matters, to be members of the Boundaries Commission; and
  - (ii) for a term of six years or until they attain the age of 60 years, whichever shall first occur, with effect on and from 9th March, 2005.

I, Paulias Matane, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 7(1)(b) and 8 of the National Housing Corporation Act 1990 and Section 10 of the Regulatory Statutory Authorities (Appointment to Certain Offices) Act 2004 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby:—

- (a) revoke the appointment of Rahim Milani as Acting Chairman of the National Housing Corporation Board and published in *National Gazette* No. G39 of 20th March, 2003; and
- (b) appoint:—
  - (i) Nenes Wurin, a person with professional experience in senior management and corporate planning, under Sections 7(1)(b)(i) and 8(1) of the Act to be a member and Chairman; and
  - (ii) Thomas Bullen, a person with professional experience in architecture and town planning, under Section 7(1)(b)(ii) of the Act to be a member; and
  - (iii) Jack Pidik, a person with experience in training and industrial relations under Section 7(1)(b)(iii) of the Act to be a member; and
  - (iv) Maria Andrew, a representative of the National Council of Women, under Section 7(1)(b)(iv) of the Act to be a member; and
  - (v) Pastor Dickson Dikion, a representative of the Melanesian Council of Churches under Section 7(1)(b)(v) of the Act to be a member; and
  - (vi) Kaminiel Warkia, on the Minister's nomination under Section 7(1)(b)(vi) of the Act to be a member, of the National Housing Corporation Board for a period of three years, with effect on and from the date of publication of this instrument in the *National Gazette*.
