## REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEAD

- I, Paulias Matane, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(1A) of the Constitution and Section 31A of the *Public Services (Management) Act* 1995, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council given after consultation with the Public Services Commission, hereby:—
  - (a) revoke the appointment of David Tibu as Acting Secretary for the Department of Labour and Industrial Relations dated 10th May, 2004 and published in the *National Gazette* No. G49 of 13th May, 2004; and
  - (b) appoint David Tibu to be Secretary for the Department of Labour and Industrial Relations for a period of four years,

with effect on and from 18th May, 2005.

#### **GREETINGS!**

WHEREAS the Constitution of the Independent State of Papua New Guinea, by Section 249, provides, amongst other things, that every Member of the Bougainville House of Representatives shall, before entering upon the duties of or exercising any of the powers of that Office, make the Declaration of Loyalty and the Declaration of Office before a person appointed for the purposes by the Head of State, in the forms set out in Section 6 and Schedule 3 respectively of the Constitution.

Now therefore, I, Paulias Matane, G.C.M.G., K.St.J., Governor-General, acting with, and in accordance with, the advice of the National Executive Council, hereby appoint you to administer the Declarations to those Members of the House of Representative as are present in the Chamber of the House on the fifteen day of June, Two thousand and five.
