DECLARATION TO PROHIBIT MOVEMENT OF COCOA PLANTS AND OTHER ALTERNATE PLANTS OF THE ASIAN COCOA POD BORER FROM AITAPE DISTRICT TO OTHER AREAS OF SANDAUN PROVINCE AND OTHER PARTS OF PAPUA NEW GUINEA

I, Sasa Zibe, Minister for Agriculture and Livestock, by virtue of the powers conferred by Section 16 of the *Plant Disease and Control Act* (Chapter 220) and all other powers me enabling, hereby declare the prohibition of introduction of cocoa plants, parts and beans to other provinces in Papua New Guinea derived from Aitape District of the Sandaun Province.
