Local-level Government Administration Act 1997

PROCLAMATION

ESTABLISHMENT OF THE KOKODA TRACK LOCAL-LEVEL GOVERNMENT SPECIAL PURPOSES AUTHORITY

WHEREAS Section 42(1) of the Local-level Government Administration Act 1997 provides that the Head of State, acting on the advice of the National Executive Council, may, by proclamation, establish a Local-level Government Special Purposes Authority in and for the area of one or more Local-level Governments.

Now therefore, I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 42(1) of the Local-level Government Administration Act 1997 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby establish Kokoda Track Local-level Government Special Purposes Authority within Koiari Rural Local-level Government areas of Central Province as specified under Paragraph (b), as a Local-level Government Special Purposes Authority, and I do further proclaim and specify that the Kokoda Track Local-level Government Special Purposes Authority:—

- (a) is established for the general purpose of assisting the implementation of the functions of the:—
 - (i) Koiari Rural Local-level Government; and
 - (ii) Kokoda Rural Local-level Government; and
- (b) applies to the areas covered by:—
 - (i) wards number 5 (Depo), 6 (Vesulogo), 15 (Bodiri), 16 (Kagi), 17 (Efogi) and 18 (Manari) of Koiari Rural Local-level Government; and
 - (ii) wards number 1 (Asimba), 2 (Kovelo), 4 (Amada), 5 (Kokoda Station), 7 (Kebara), 8 (Abuari), 9 (Alola) and 10 (Waju) of Kokoda Rural Local-level Government, as are defined in the proclamations of those Local-level Governments made in accordance with the provisions of Section 27(1) of the Organic Law on Provincial Governments and Local-level Governments; and
- (c) shall implement any particular functions of the:—
 - (i) Koiari Rural Local-level Government; and
 - (ii) Kokoda Rural Local-level Government,
 - as those Local-level Governments may determine from time to time and as may be delineated in a Memorandum of Understanding; and
- (d) shall focus on the significance of the Kokoda Track due to its part in World War II and promote this legacy for present and future generations and promote tourism related activities; and
- (e) shall, in addition to any other functions as may be determined from time to time, act as an agent for the National Government as provided for under Section 48(4) of the Local-level Governments Administration Act 1997; and

Establishment of the Kokoda Track Local-level Government Special Purposes Authority:—continued

- (f) shall have a management committee consisting of ten members as follows:—
 - (i) one person, not being a Councillor, appointed by the Koiari Rural Local-level Government;
 - (ii) one person, not being a Councillor, appointed by the Kokoda Rural Local-level Government;
 - (iii) one person, not being a Councillor, appointed by the Koiari Rural Local-level Government to represent landowners in their Kokoda Track Area;
 - (iv) one person, not being a Councillor, appointed by the Kokoda Rural Local-level Government to represent landowners in their Kokoda Track Area;
 - (v) the District Administrator of the Kairuku-Hiri District or his nominee;
 - (vi) the District Administrator of the Sohe District or his nominee;
 - (vii) the Executive Officer of the Tourism Promotion Authority or his nominee;
 - (viii) the Executive Officer of the National Cultural Commission or his nominee;
 - (ix) one person appointed by tour operators involved with the Kokoda Track;
 - (x) one person appointed by the Port Moresby Sub-Branch of the Returned and Services League of Australia; and
- (g) shall have a staff consisting of a manager appointed by the Authority and such other additional officers as it may consider necessary to appoint from time to time; and
- (h) shall determined the period of employment and other terms and conditions of employment of the staff; and
- (i) shall be managed and funded as the management committee may determine, subject to:
 - i) any requirement of fulfilling any agreements made with the:—
 - (A) Koiari Rural Local-level Government; and
 - (B) Kokoda Rural Local-level Government,
 - as concerns the implementation of functions of those local-level governments; and
 - (ii) any requirement of fulfilling functions as an agent of the National Government as determined in this Proclamation; and
- (j) shall advise the Minister responsible for cultural and tourism matters on any matter concerning the responsibilities of the National Government effecting the Kokoda Track people that the Authority or the Minister may consider necessary; and
- (k) shall advise the Minister responsible for provincial government and local-level government matters on all other matters that the Authority or the Minister may consider necessary; and
- (1) under its management committee shall consider details of its management, staffing, finances, discipline, salaries and remunerations, and any other necessary matter; and
- (m) may, and if the Minister so determines shall, have details of its management, staffing, finances, insurance, audit, discipline, salaries and remunerations, and any other necessary matter, determined by a constitution, local-level law, or other manner approved of by the Minister, and such a document shall be subject to approval by the Minister; and
- (n) may, in the event of difficulties, appeal to the Minister and any decision of the Minister shall be final; and
- (o) may be known as the Kokoda Track Authority; and
- (p) shall come into operation on the date of signature of this Proclamation by the Head of State, acting on advice.

Professional Engineers Registration Act (1986)

NOTIFICATION OF REGISTRATION OF PROFESSIONAL ENGINEERS

I, hereby notify that the engineers specified in the Schedule hereto are entitled to practice as Professional Engineers in accordance with Part V of the Act and to use the identifying title 'Reg Eng' after their names. A person, Company, Statutory Body, Government Body, or Organisation which employs an unregistered person as a Professional Engineer is guilty of an offence. An un-registered person who practices as a professional engineer is guilty of an offence. Applications for exemption from registration and the provisions of the Act may be made under Section 17.

Employers of Professional Engineers should note:—

- (1) a list, which shall cancel all previous lists, of persons currently registered under the Act shall appear annually in the National Gazette during the month of January; and
- (2) an addendum to the annual list, of persons subsequently registered, or de-registered, shall appear as required; and
- (3) Certificates issued to persons registered under this Act must be displayed in a prominent position in the office given as the place of practice.
