EXEMPTION FROM IMPORT DUTY EXEMPTION FROM IMPORT EXCISE DUTY EXEMPTION FROM GOODS AND SERVICES TAX

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act* 1990 and Section 25(8) of the *Goods and Services Tax Act* 2003, and Section 3(1)(a) of the *Excise Tariff Act* (Chapter 107) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby with effect on and from 1st of January, 2006 up to 30th June, 2006, exempt from import duty, import excise duty and goods and services tax on the import of Motor vehicles, building materials and other goods directly purchased or contributed for the sole use in the National Event organized by the PNG Events Council for the hosting of Asia Carribean Pacific (ACP) and European Union (EU) Joint Ministers meeting held on the 28th May to the 2nd June, 2006, subject to the conditions specified in the Schedule.

This notice revoke and replaces National Gazette No. G37 of 21st February, 2006.

Building Materials and Other Goods

Importers will submit a Statutory Declaration with an acknowledgement letter from the Director-General of the PNG Events Council together with the Customs Entry form stating that the goods imported are for the sole use in the hosting of the ACP/EU Joint Ministers meeting and that they will be liable for the full duty payable on the import if it is not so used.
