Organic Law on National and Local-level Government Elections

EXTENSION OF TIME

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers vested in me by Section 177 of the *Organic Law on National and Local-level Government Elections* and upon the advice of the Electoral Commission that special circumstances exist which warrant time to be extended for those electorates (in that bad weather conditions may delay distribution of polling materials and late deployment of polling teams to polling places that may result in late polling and delay in the movement of security personnel within the provinces), hereby extend time of polling in electorates listed below for the indicated dates:

- (i) All electorates in West Sepik Province
 —10th July, 2007 to 14th July, 2007 and if necessary 16th July, 2007;
- (ii) All (4) electorates in Morobe Province
 (Bulolo, Finschhafen, Kabwum and Menyamya)
 —10th July, 2007 to 14th July, 2007 and if necessary 16th July, 2007;
- (iii) All electorates in Madang Province
 —10th July, 2007 to 14th July, 2007;
- (iv) All electorates in East Sepik Province
 —10th July, 2007 to 14th July, 2007 and if necessary 16th July, 2007;
- (v) All electorates in Gulf Province and Central Province
 —10th July, 2007 to 14th July, 2007 and if necessary 16th July, 2007;
- (vi) One electorate in Bougainville
 (Attols in North Bougainville)
 —10th July, 2007 to 14th July, 2007.
