# NOTICE OF EXTEND THE REVIEW PERIOD OF EDA RANU'S CURRENT PRICING ARRANGEMENTS

ON the 3rd July, 2003 the Minister for Treasury lodged an application with the Independent Consumer and Competition Commission ("the Commission") for a review of the current pricing arrangements that apply to Eda Ranu under Section 25A(2) of the *Prices Regulation Act* (Chapter 320).

Notice is hereby given pursuant to Section 25C(2), that the Commission hereby extends the 90 days review period allowed for the review of Eda Ranu's current pricing arrangement under Section 25C(1) by a further 30 days from 1st October, 2007 to 31st October, 2007.

Therefore, on or before 31st October, 2007, the Commission will form a decision on Eda Ranu's Capital Expenditure and its impact on the price path applying to Eda Ranu's water and sewerage services.
