NOTICE OF APPLICATION FOR REGISTRATION OF AN ASSOCIATION AS AN INDUSTRIAL ORGANISATION

- (g) All public employees not included in sub-rule (a), (b), (c), (d), (e), (f) of this rule.
- (h) All casual employees in the Bougainville Public Service",

Any Association or person who desires to object to the registration of the Association may do so, by lodging with me a notice of objection thereto, together with a Statutory Declaration within thirty-five (35) days after the publication of this notice and, by serving on the association within seven (7) days after the notice of objection has been lodged, copies of the notice of objection and Statutory Declaration so lodged, as required by Section 14 of the *Industrial Organisations Act* (Chapter No. 173).
