Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the Customs Tariff Act 1990, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, exempt from import duty of materials, supplies, equipments, spare-parts and items which are set out in Schedule 2 of the Project Agreement which are related to the construction and operation of the Cloudy Bay FMA Development Project Agreement between the Independent State of Papua New Guinea and the Central Provincial Government, Northern District Sawmilling and Timber Company Limited in the Central Province.
