Public Services (Management) Act 1995

REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEAD

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(1A) and (1C) of the Constitution, and Section 31A of the *Public Services (Management) Act* 1995, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council from a list of persons recommended by the Public Services Commission, hereby:—

- (a) revoke the appointment of Pepi Kimas as Acting Secretary for the Department of Lands and Physical Planning as published in the National Gazette No. G105 of 2006; and
- (b) appoint Pepi Kimas as Secretary for the Department of Lands and Physical Planning for a period of four years,
