Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act* 1990, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, exempt from import duty, on the import of materials to put up Model Houses for low, medium, high and executives houses which are either brick, steel or timber pre fabricated houses and materials as set out in Schedule of the Project which is established by the Special Purpose Company of the National Housing Corporation.

Excise Tariff Act (Chapter 107)

EXEMPTION FROM EXCISE DUTY

I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 3(1)(a) of the *Excise Tariff Act* (Chapter 107), and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, exempt from excise duty on the imports of the items which are set out in the Schedule below in relation to the Morobe Consolidated Goldfields Limited in the Morobe Province for the construction phase of the Hidden Valley Mining. The exemptions are to apply from 15th November, 2006 for the duration of the construction phase of the Hidden Valley Mine.
