## DECLARATION OF LIBANO-HOSE WILDLIFE MANAGEMENT AREA AND APPOINTMENT OF LIBANO-HOSE WILDLIFE MANAGEMENT COMMITTEE

I, William Duma, Minister for Environment and Conservation, by virtue of the powers conferred by Section 15 and 16 of the Fauna (Protection and Control) Act (Chapter 154) and all other powers me enabling, having consulted with the owners of the land described in Schedule 1, hereby:—

- (a) declare the area described in Schedule 1 to be a Wildlife Management Area to be known as Libano-Hose Wildlife Management Area for the purposes of that Act; and
- (b) establish a Wildlife Management Committee to be known as the Libano-Hose Wildlife Management Committee; and
- (c) specify that the number of members of that Committee shall be 9; and
- (d) appoint each person specified in Schedule 2 to be a member of that Committee.
