REVOCATION OF APPOINTMENT AND APPOINTMENT OF CHIEF JUSTICE OF PAPUA NEW GUINEA

- I, Grand Chief Sir Paulias Matane, G.C.L., G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 169(2) of the Constitution and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council given after consultation with the Minister for Justice and Attorney-General, here-
 - (a) revoke the appointment of Sir Mari Kapi as Chief Justice of Papua New Guinea; and
 - (b) appoint Sir Salamo Injia as Chief Justice of Papua New Guinea for a period of ten years, with effect on and from 31st October, 2008.
