Independent Consumer and Competition Commission Prices Regulation Act

PUBLIC NOTICE

MAXIMUM MARGINS FOR WHOLESALE, RETAIL AND DRUM FILLING OF PETROLEUM PRODUCTS

THE 2004 petroleum products prices order, which applies to fuel distributors and retailers, sets out a five years price path for wholesale and retail maximum margins, with the margins being automatically adjusted annually, starting in 2005, by 1% less than the inflation rate. On that basis, the adjustments for 2008 will be +0.3 toea/litre for the wholesale margin and +0.2 toea/litre for the retail margin. This means maximum margins for 2008 will be as follows:

These rises are a very small part of the overall price of fuel-when added together; they amount to less than 0.15%, or one six hundreth, of the price of a litre of fuel. These small price rises will go to retailers and wholesalers, most of whom are independent of InterOil, and who are not responsible for the recent substantial hike in base fuel prices, which arose from InterOil unilaterally changing the method of calculating base fuel prices.

However, it is also important to note that these small price rises are not mandatory in that they simply raise the maximum margins which may be charged. Therefore, wholesalers and retailers are free to charge their customers less than the maximum margin if they wish.

Maximum Margins for Wholesale, Retail and Drum Filling of Petroleum Products:—continued

While these price adjustments resulting from an increase to the maximum margins for petroleum products are automatic and have been since 2005, and notwithstanding that the adjustments are small (in total, only half a toea per litre), because of the recent large rises in the retail price of fuel, and the hardship this is causing consumers, the ICCC asks wholesalers and retailers to consider not adjusting their margins up to the new allowable maximum, but to keep their margins at the 2007 level for as long as possible in the interests of their customers, even though the ICCC recognises that the independent wholesalers and retailers are themselves experiencing distribution cost increases due to the increases in base fuel prices resulting from InterOil's recent actions.

LAND AVAILABLE FOR LEASING

A. APPLICANT:

Applicants or Tenderers should note-

- 1. Full name (block letters), occupation and address;
- 2. If a Company, the proper Registered Company name and address of the Company representative;
- 3. If more than one person, the tenancy desired and, if tenancy in common, the division of shares.

Applicants or tenderers should note-

- 4. That a lease cannot be held in a name registered under the Business Names Act only; and
- 5. That in the case of death in joint tenancy, the deceased partner's interest vests in the surviving partner and, in the case of tenancy in common, the deceased partner's interest vests in his estate.

E. TENDER OF LAND AVAILABLE PREFERENCE:

The preference should be clearly indicated. In cases where there are more than 20 preferences the additional preferences may be shown on attachment.
