Prices Regulation Act (Chapter 320)

#### PUBLIC MOTOR VEHICLE PRICES ORDER 2009

MADE by the Independent Consumer and Competition Commission under Section 21 of the *Prices Regulation Act* (Chapter 320) pursuant to Schedule A of PMV & Taxi Services Prices Order 2007 and shall take effect on 1st January, 2009.

Consistent with its 2007 final determination, the Commission has:

- . Calculated the fare adjustment due for urban PMVs to be a 15.17% increase.
- An increase in fares will however not be approved as a cruicial precondition for fare increase does not appear
  to have been satisfactorily met for service quality requirement within urban areas, in that;
- (a) some PMV operators are not completing their routes; and
- (b) some PMV operators are not allowing consession passengers to enter their vehicles or are forcing them to exit the vehicles before the end of the route.
- The Commission will conduct an assessment of service quality against the requirements expressed in its 2007 final determination during the next six months and review its decision by 1st July, 2009.
- In the meantime the current fares for urban PMV's as published in the *National Gazette* No. G175 of 15th November, 2007 will continue to apply from 1st January, 2009.

All definitions, conditions as determined pursuant to *National Gazette* No. G175 of 15th November, 2007 shall remain.
