THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 94 of the Constitution hereby suspend Michael Ogio, G.C.L., G.C.M.G., K.St.J., as the Governor-General of Papua New Guinea for his refusal to act in accordance with advice of the Parliament with whose advice he is obliged to act, to appoint Peter O'Neill as the Prime Minister of Papua New Guinea, pending any resultant action by the Parliament with effect on and from 14th December, 2011.
