Covec (PNG) Ltd wishes to engage the services of experienced and skilled non-citizens specialist who will be coming in to work on the Improvement Works and Long Term Performance Base Maintenance Services for Highlands Highway Road. The Project is a result of an agreement between the Government of PNG and the concern company.

These exemptions are granted in accordance to Section 51 of the *Employment of Non-Citizens Act 2007*. The exemptions are always in the interest of the nation and for a good cause, in particularly, the Project's contribution to the country's infrastructure development and up skilling and training of our human resources.

The exemptions are granted from 6th September, 2013 to 6th September, 2016.

Specific conditions placed against the exemptions are:-

- (1) For the company to pay a fee of K3000.00 for each employee to the Department of Labour and Industrial Relations;
- (2) For the company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment opportunities (decent work, fair pay, promotions etc.) to citizen workers;
- (4) For the company to provide opportunities for human resource development and skills training to its employees.
