CONSTITUTION

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Peter O'Neill, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 10th August, 2012 and published in the *National Gazette* No. G304 of 10th August, 2012 (as amended)—

(a) in Schedule 1 (Prime Minister)—

- (i) Column 3, by inserting “PNG Sustainable Development”, and
- (ii) Column 4, by inserting the following in alphabetical order:

Mining (Ok Tedi Agreement) Act (Chapter 363);

Mining (Ok Tedi Supplemental Agreement) Act (Chapter 363A) except powers relating to conservation matters);

Mining (Ok Tedi Third Supplemental Agreement) Act (Chapter 363C) (except powers relating to environment and conservation matters);

Mining (Ok Tedi Fourth Supplemental Agreement) Act (Chapter 363D) (except powers relating to environmental and conservation matters) except s. 9(3)(d);

Mining (Ok Tedi Fifth Supplemental Agreement) Act (Chapter 363E) (except powers relating to environment and conservation matters);

Mining (Ok Tedi Sixth Supplemental Agreement) Act 1986 (except powers relating to environment and conservation matters);

Mining (Ok Tedi Seventh Supplemental Agreement) Act 1986 (except powers relating to environment and conservation matters);

Mining (Ok Tedi Restated Eight Supplemental Agreement) Act 1995 (except powers relating to environment and conservation matters);

Mining (Ok Tedi Mine Continuation) (Ninth Supplemental Agreement) Act 2001 (except powers relating to environment and conservation matters); and

(b) in Schedule 3 (Treasury), Column 3, by deleting “PNG Sustainable Development”; and

(c) in Schedule 28 (Mining), Column 4, by deleting the following:

Mining (Ok Tedi Agreement) Act (Chapter 363);

Mining (Ok Tedi Supplemental Agreement) Act (Chapter 363A) except powers relating to conservation matters);

- Mining (Ok Tedi Third Supplemental Agreement) Act* (Chapter 363C) (except powers relating to environment and conservation matters);

- Mining (Ok Tedi Fifth Supplemental Agreement) Act* (Chapter 363E) (except powers relating to environment and conservation matters);
- Mining (Ok Tedi Sixth Supplemental Agreement) Act* 1986 (except powers relating to environment and conservation matters);
- Mining (Ok Tedi Seventh Supplemental Agreement) Act* 1986 (except powers relating to environment and conservation matters);
- Mining (Ok Tedi Restated Eight Supplemental Agreement) Act* 1995 (except powers relating to environment and conservation matters);
- Mining (Ok Tedi Mine Continuation) (Ninth Supplemental Agreement) Act* 2001 (except powers relating to environment and conservation matters).
