PART IV—PROVINCIAL PHYSICAL PLANNING BOARDS

I, Hon, Melchior Safuna, MPA being the Chairman of the Lands and Physical Planning, charged with responsibility for Physical Planning matters in the East Sepik Province, acting in accordance with Section 20(1), (2), (3) and (4) of the *Physical Planning Act 1989* hereby declare the membership of the East Sepik Provincial Physical Planning Board to be as follows:—

In respect of Section 20(1)(a)—Richard Kombo—the A/Provincial Administrator, as an ex-officio member; and

In respect of Section 20(1)(b)—Samuel Moses—the officer in charge of National Works function in the province, as an ex-officio member; and

In respect of Section 20(1)(c)—James Baloiloi—the officer in charge of Provincial Works function in the province, as an ex-officio member; and

In respect of Section 20(1)(d)—Dau Waskiay—the Provincial Lands Advisor, as an ex-officio member; and

In respect of Section 20(1)(e)—Francis Sumanob—appointed to represent the private business sector in the province, from nominations received from the Chamber of Commerce; and

In respect of Section 20(1)(g)—Supt Joe Poma—PPC, National Interest Rep the member appointed by the Minister in accordance with Section 20(a) of the *Physical Planning Act 1989*; and

In respect of Section 20(1)(h)—Titus Magoipen—Appointed to represent professions related to Physical Planning; and

In respect of Section 20(1)(h)—up to three other members who shall include one representatives from

- (i) Sporting Bodies and groups—Mrs Carol Tarere
- (ii) Churches; or—Father Casper Talmal
- (iii) Settlements—Anton Namuesh

In respect of Section 20(5)(a)—Wewak Town Manageress, Mrs Theresa Golman and Geno Harembe to represent Wewak Urban Community.

The above mentioned members, in respect of Section 20 (1)(e), (f), (g) and (h) are appointed for a period up to three (3) years from the date of this Notice.

It is further declared, in accordance with Section 22 and from the above stated membership after receiving advice from the Chief Physical Planner, the Chairman of East Sepik Provincial Planning Board shall be the Provincial Administrator, Richard Kombo and the Deputy Chairman shall be Francis Sumanop representing Chamber of Commerce for a period of three (3) yeras effective from the date of gazettal.
