## REVOCATION OF APPOINTMENT AND APPOINTMENT OF CHAIRMAN AND DIRECTORS OF THE INDEPENDENT PUBLIC BUSINESS CORPORATION BOARD

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Sections 11 and 12(1) of the *Independent Public Business Corporation of Papua New Guinea Act 2002* and all other powers it enabling, hereby—

- (a) revoke the appointment of Thomas Webster and Felicia Dobunaba as Directors of Independent Public Business Corporation Board; and

- (b) revoke the appointment of Thomas Webster as Chairman of Independent Public Business Corporation Board and;
  - (c) appoint each person specified in Column 2 of the Schedule to be a member of the Independent Public Business Corporation of Papua New Guinea Board appointed under the provision specified in Column 1 of the Schedule opposite his name to represent the interest specified in Column 3 for a period of three years; and
